Deadline near for same-sex marriage ruling

The fate of Arizona's marriage law could be decided this week.

U.S. District Judge John Sedwick stated last week that he believes a 9th Circuit U.S. Court of Appeals ruling declaring Idaho's and Nevada's marriage restrictions unconstitutional applies to Arizona as well.

Sedwick, an Alaska judge who often helps pick up Arizona cases, gave the parties in two lawsuits challenging Arizona's law until Thursday to file briefs arguing how the 9th Circuit decision does or does not apply.

Arizona is part of the San Francisco-based circuit.
